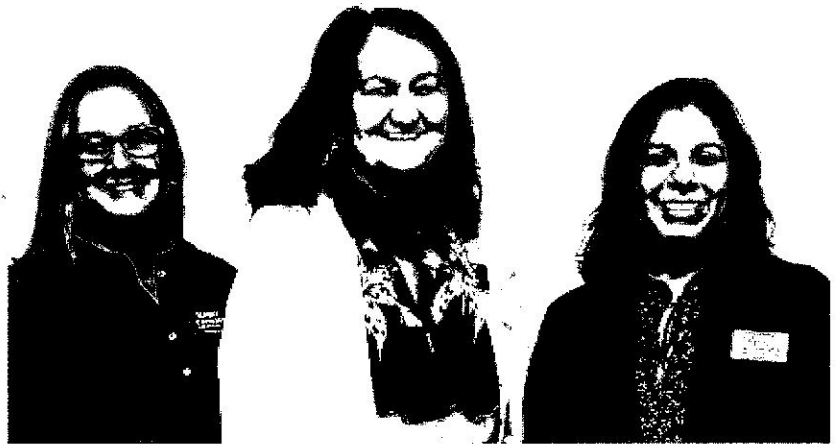

Surrey provides customized help with bills, mail, bank statements, tax information, budgeting, insurance paperwork and government forms.

The Personal Finance Manager will work with you to develop a customized service plan that may include:

- Develop a budget and track income and expenses
- Organize and purge files, pay bills and handle billing inquiries and disputes
- Sort, review and handle mail
- Reconcile banking and other financial accounts
- Review and advise on household utility services and plans
- Advise on selecting medical/prescription plans and manage medical insurance claims and disputes
- Review insurance policies, explain coverage and manage claims. Advise on LTC policies and handle claims.
- Manage finances using Quicken software
- Compile and organize tax information
- Determine eligibility and file applications for government benefits
- Assist with financial matters relating to funeral and cremation preplanning
- Assist with financial and administrative tasks after the loss of a loved one

Surrey offers free and fee-based transportation services designed to help you get where you need to go. Rides are provided by volunteers, Surrey drivers, and through partnerships with ROVER (Chester County) and DELGO Community Transit (Delaware County).

Reserve a ride for your doctor's appointment, hairdresser visit, grocery shopping, or even to Philadelphia Airport. Our staff coordinators work with you to find the best option for your schedule.

Special Services

Surrey operates wheelchair accessible vans that enable our drivers to provide rides to individuals who use a wheelchair. Priority is given to Surrey members.

Surrey's holistic approach also extends to transportation. Surrey can assist with rides to and from medical procedures that require anesthesia such as endoscopy, colonoscopy, and cataract surgery. First Time Clients

If you are new to Surrey transportation, your first step will be to register with ROVER for Chester County residents (484-696-3854) or DELGO if you are a Delaware County resident (610-490-3960) to verify your eligibility as a transportation client. There is no charge for this registration, but it can take up to 5 days.

Once you are registered, please call SURREY TRANSPORTATION 610-993-9493, at least 5 - 7 business days before you need your ride so that we may provide the best service. If you use a wheelchair or are traveling to the airport or into Philadelphia, please call 14 business days in advance.
